BYLAW NO. 1169-2026

A BYLAW OF THE TOWN OF OXBOW IN THE PROVINCE OF SASKATCHEWAN TO SET THE MILL RATE, MILL RATE FACTORS AND BASE TAX

WHEREAS Section 283(2) of *The Municipalities Act* requires the Council of the Town of Oxbow to establish a levy on all taxable assessments in the municipality; and

WHEREAS Section 39 of *The Municipalities Regulations* establishes classes of property; and

WHEREAS Section 285(1) of *The Municipalities Act* authorizes the Council of the Town of Oxbow to establish a uniform mill rate factor to a class of property; and

WHEREAS Section 290 of *The Municipalities Act* authorizes the Council of the Town of Oxbow to establish a base tax for different classes of property; and

WHEREAS Subsection 284 *The Municipalities Act* provides the council of the Town of Oxbow to establish mill rate factors tax for different classes of property.

NOW THEREFORE, the Council of the Town of Oxbow, in the Province of Saskatchewan, enacts are follows:

Title

1. This bylaw may be referred to as the Tax Levy Bylaw.

Uniform Mill Rate

2. The uniform Mill Rate shall be 7.26 mills.

Mill Rate Factors

3. The mill rate factors to be applied to the uniform mill rate levied against all taxable property for the municipal purposes in the property classes established by subsection 42(2) of *The Municipalities Regulations* are as set out in Table 1 and forming part of this bylaw.

Base Tax

4. The base taxes to be applied to all taxable property for municipal purposes in the property classes established by subsection 42(2) of *The Municipalities Regulations* are as set out in Table 2 attached to and forming part of this bylaw.

Property classification re: base tax

5. Where a property is classified in more than on property class, base tax calculations shall be based on the higher of the applicable classes.

Coming into force

6. This Bylaw comes into effect on the date on which it receives third reading and is adopted by Council.

Repeal of Former Bylaw

7. Bylaw No. 1150-2024 is hereby repealed.
